Applicant shall provide the following information (attach to this form):

1. Name. Name of owner, operator, or lessee of vehicle concerned.
2. Description of load. Manufacturer, model number, etc.
3. Identification of vehicle. License number, if registered, otherwise serial number, unit number.
4. Capacity. Licensed capacity of vehicle subject to registration, if overweight is involved.
5. Map. Provide map showing preferred route. List origin, destination, and names of roads to be traveled.
6. Date(s) of movement.
7. If House Trailer. License number if privately owned.
8. Insurance. Evidence of insurance, if required.
9. Necessity for movement.
10. Special Instructions. Special instruction regarding address to which permit is to be sent and any other pertinent information.
11. Copies of Permits issued by other agencies for this load.
12. Sketch. Provide a sketch of the vehicle and load, showing the following:
 - a. Physical dimensions, including height, width and length
 - b. Axle spacing
 - c. Tire size and configuration
 - d. Axle group loadings
 - e. Gross vehicle weight

SECTION II – STANDARD CONDITIONS

1. A permit is required for any loads exceeding the limits of Idaho Code §49-1001 (loads) and §49-1010 (size).
2. Permittee is responsible for damage to roads per Idaho Code §49-1006.
3. Permitting and fees are required per Idaho Code §49-1004.
4. No permit will be issued where axle group loadings exceed Idaho Code §49-1010 limits, except where applicant provides an analysis showing the load will not damage the ballast section or structures of the route to be traveled.
5. Any ballast section analysis shall be performed by an engineer qualified in the “H1c Materials Report Phase 3” category on the Idaho Transportation Department Term Agreement List.
6. Any structural analysis shall be performed by the Idaho Transportation Department Bridge Section, or by an engineer qualified in the “A4 Bridges & Structures Load Rating” category on the Idaho Transportation Department Term Agreement List.
7. The permit shall be subject to termination on all or any portion of the designated roads set forth herein, by the Director upon two (2) hours verbal notice to the designated representative of the Permittee at the phone number provided on this form. Verbal notice shall be immediately followed by written notice. The decision to terminate shall be based on the conditions of the road(s). The

- Permittee is entitled to request a review of the Director's decision to terminate.
8. Any actions or situations deemed dangerous by the Director will, upon verbal and/or written demand, cause immediate temporary or full termination of the Permit.
 9. Any sign damage done by Permittee shall be reported immediately to the Nampa Highway District.
