REGULAR MEETING OF THE BOARD OF COMMISSIONERS OF CANYON HIGHWAY DISTRICT NO. 4 April 17, 2019

Chairman Youngblood called the meeting to order at 9 a.m.

REVIEW AND APPROVE AGENDA INCLUDING AMENDMENTS

Secretary Franks presented the Board with the revised agenda as posted on April 16, 2019. Commissioner Gibbons made a MOTION TO ACCEPT THE REVISED AGENDA AS PRESENTED. Commissioner McEvoy SECONDED the motion. The motion passed unanimously in favor.

NEW BUSINESS

1. 11th Avenue and Ustick Road Intersection - NHD Commissioners: Eric Shannon, engineer for Nampa Highway District (NHD), stated that he was present to discuss the memorandum of understanding (MOU) for the 11th Avenue and Ustick Road Roundabout Project. Engineer Shannon stated that the NHD Staff has analyzed the crash data in order to make intersection improvement recommendations for their District's planning and budget. NHD Staff has proposed to its Board that the intersection be converted to a roundabout because of the growing crash history and to continue the roundabout corridor along Ustick Road. The estimated cost of the project is \$2 million that would be split equally between Canyon Highway and Nampa Highway districts. Engineer Shannon would like to hire the consultant as soon as possible to begin the acquisition of the rightof-way since three corners of the intersection are currently farm ground. Engineer Shannon estimates that construction would not begin until 2021/2022. Engineer Richard and Commissioner Gibbons discussed the District's revenue and expenditure analysis, including the shortfalls when programming capital projects. Engineering Richard added that the District would look for funding for the design and right-of-way acquisition but the Middleton Road and Linden Road and Indiana Avenue and Homedale Road Roundabout projects are the District's current priority. Engineer Shannon thanked the Board for its consideration and asked that the District to be in contact with him as soon as possible regarding the design and right-of-way acquisition funding. The current draft memorandum of understanding (MOU) can be modified to only include the design and right-of-way services.

At 9:11 a.m., Eric Shannon, Devin Muchow, Randy Noble, Dick Smith and Bryce Millar from Nampa Highway District excused themselves.
